## **Glossary of Terms**

1985 Act (AJA)/ Administration of Justice Act	the Administration of Justice Act 1985 which created the <i>CLC</i> and provided it with its powers to regulate <i>licensed conveyancer</i> s
1990 Act (CLSA)/ Courts & Legal Services Act	the Courts & Legal Services Act 1990 which amended parts of the <b>1985 Act</b> and entitles the <b>CLC</b> to license and regulate <b>Licensed CLC Practitioners</b> , apply to regulate <b>probate</b> , <b>litigation and advocacy</b> activities in addition to <b>conveyancing</b> services (the CLC is currently authorised to license and regulate <b>probate</b> services)
2007 Act (LSA)	the Legal Services Act 2007 which created the <i>Legal Services Board</i> , the Office for Legal Complaints ( <i>Legal Ombudsman</i> ), authorised <i>Approved Regulators</i> to regulate <i>Authorised Persons</i> and enabled the development of new forms of legal practice known as <i>Alternative Business Structures</i> and the licensing of these bodies by <i>Licensing Authorities</i>

#### <u>A</u>

Access to Justice	the recognition of, and response to, potential and actual, consumer needs. This may take the form of provision of a greater range of services and methods of accessing these services, lower prices, extended opening hours, accessibility, online provision, or other factors
Accounting Records	includes all documents or records on a <i>Durable Medium</i> necessary for the operation of any system of book-keeping
Accounting Period	the period for which the accounts of the <i>CLC</i> Body are ordinarily made up, provided however that it must begin at the end of the previous Accounting Period and cover twelve months (except with the prior written consent of the CLC)
Accountant's Report	a report signed by the <i>Reporting Accountant</i> in such form as determined by the CLC relating to Client Money held or received by each body in respect of each Accounting Period

Adjudication Panel	established:
	<ul> <li>to determine appeals against determinations made by the CLC relating to CLC Lawyers and CLC Bodies and relating to owners, Managers and employees of CLC Bodies</li> </ul>
	<ul> <li>to determine applications for review in relation to regulatory and enforcement decisions made by a <i>CLC Authorised Officer</i>, save for those appeals which are reserved to the Discipline and Appeals Committee;</li> </ul>
	to determine allegations of misconduct referred to it
Advice	the provision of a personal recommendation to a <i>Client</i> , either upon their request or at the initiative of the insurance distributor, in respect of one or more insurance contracts
Advocacy	referred to at schedule 2 of the <b>2007 Act</b> as rights of audience and includes the right to appear before and address a court, including the right to call and examine witnesses
Advocacy Licence	a <i>licence</i> issued by the <i>CLC</i> to provide <i>advocacy</i> services, under Part 1 of Schedule 8 of the <i>1990 Act;</i> this will only be applicable if the <i>CLC</i> 's application to regulate this activity is successful
Aged Balance	<ul> <li>(a) a sum outstanding to the credit of an individual ledger account;</li> <li>(b) where there has been completion of a legal transaction or it has become abortive; and</li> <li>(c) there has been no movement on the account for a period in excess of 12 months except for monies held in accordance with the terms of an undertaking (in which case the 12 month period will begin from the date on which such monies are released)</li> </ul>
Alternative Business Structure (ABS)	a body which provides legal services to the public and in which a nonlawyer is a <i>manager</i> and/or <i>owner</i> as provided at s.72 of the <i>2007 Act</i> ; for licensing purposes these bodies are referred to as <i>Licensed (ABS) Bodies</i>
AML/CTF Legislation - Anti Money Laundering and Combating the	legislation directed to the prevention of Money Laundering and Combating the Financing of Terrorism , and in particular, the:
Financing of Terrorism  Legislation	Proceeds of Crime Act 2002 (as amended);
Echiation	<ul> <li>Terrorism Act 2000 (as amended); and</li> <li>Money Laundering Regulations 2017 - SI 2017/692 (the ML Regulations)</li> </ul>
Ancillary Insurance Intermediary	any natural or legal person, other than a credit institution or an investment firm as defined in points (1) and (2) of Article 4(1) of Regulation (EU) No 575/2013 of the European Parliament and of the Council (1), who, for

	remuneration, takes up or pursues the activity of insurance distribution on an ancillary basis, provided that all the following conditions are met:
	<ul> <li>a) the principal professional activity of that natural or legal person is other than insurance distribution;</li> </ul>
	b) the natural or legal person only distributes certain insurance products that are complementary to a good or service;
	<ul> <li>c) (c) the insurance products concerned do not cover life assurance or liability risks, unless that cover complements the good or service which the intermediary provides as its principal professional activity;</li> </ul>

Arrangements	methods of organisation including systems, procedures, controls, functions, roles, and processes

	b) a European Economic Area (EEA) firm of the kind mentioned in paragraph 5(d) of Schedule 3 to that Act, which has permission under paragraph 15 of that Schedule (as a result of qualifying for authorisation under paragraph 12 of that Schedule) to effect or carry out contracts of insurance of a relevant class; or
	c) a person who does not fall within paragraph (a) or (b) and who may lawfully effect or carry out contracts of insurance of a relevant class in a member State other than the United Kingdom
(CLC) Authorised Officer	the Licensing and Casework Manager employed by the CLC, or another officer of the CLC of equivalent or senior status
Authorised Person(s)	a person authorised by an <i>Approved Regulator</i> to carry on <i>reserved legal activities</i> e.g:

Bank	an institution, body, financial intermediary, or financial institution which has permission under Part 4 of the Financial Services and Markets Act 2000 to accept deposits
Beneficial Owner	the individual or company which has all the benefits and entitlements of a legal owner, even if not named or registered as the legal owner
Beneficiary	A person who derives advantage from something, for example a will, trust, or life insurance policy.
(CLC) Body	<ul> <li>an entity regulated by the CLC:</li> <li>an Alternative Business Structure (also called a Licensed Body) regulated by the CLC acting as a Licensing Authority; or</li> <li>a Recognised Body regulated by the CLC acting as an Approved Regulator</li> </ul>

Brokers	under the Professional Indemnity Insurance Code and Operating Framework this refers to the agent who sources the contract of insurance for the <i>CLC's Master Policy</i>
Building Society	a branch situated in England and Wales of a building society incorporated (or deemed to be incorporated) under the Building Societies Act 1986

Certificate of Recognition	a certificate issued by the <i>CLC</i> to a body corporate recognising it as a <i>Recognised Body</i> - under s.32 of the <i>1985 Act</i> - suitable to undertake the provision of <i>Regulated Services</i> authorized by the <i>CLC</i>
Claim	under the <i>Professional Indemnity Insurance</i> Code and Operating Framework and <i>Compensation Fund</i> Operating Framework, unless otherwise stated, this means a request of payment due under the terms of a <i>professional indemnity insurance</i> policy (including the <i>CLC PII Policy Terms</i> ) or the <i>CLC's Compensation Fund</i>
Claimant	<ul> <li>under the <i>Compensation Fund</i> Operating Framework this means any person making a <i>claim</i> for payment of a grant from the CL<i>C's Compensation Fund</i> and includes</li> <li>the personal representative where the person entitled to make a claim Claimant has died, or</li> </ul>
	the trustee in bankruptcy where the person entitled to make a <i>claim</i> has been made bankrupt
(the) CLC	the Council for Licensed Conveyancers established under s.12 of the <b>1985</b> **Act

CLC Lawyer	(property specialist) lawyer; the lawyer may be:
	A <i>Licensed Conveyancer</i> licensed to provide <i>conveyancing</i> and may also be licensed to provide probate, litigation or advocacy.
	A <i>Licensed CLC Practitioner</i> (who may be licensed to provide <i>probate</i> , <i>litigation</i> or <i>advocacy</i> activities, but not <i>conveyancing</i> services)
CLC Practice	A legal firm regulated by the Council for Licensed Conveyancers.
CLC Practitioner Services Body	A body recognised by the <i>CLC</i> as a <i>Recognised Body</i> to provide <i>probate</i> , <i>litigation</i> or <i>advocacy</i> activities, but not <i>conveyancing</i> services
CLC PII Policy Terms	the <i>CLC's professional indemnity insurance</i> policy authorised by the <i>CLC</i> under s.21 of the <i>1985 Act</i>
Client	any person or persons for whom a <b>Licensed Conveyancer</b> or <b>CLC body</b> acts in the provision of <b>Regulated Services</b> ; this may also include a person or persons who may seek the provision of Regulated Services.
	Client also includes any person for whom a Licensed Conveyancer or Body acts in the provision of Regulated Activities (and may also include a person who may seek the provision of Regulated Activities)
Client Account	a current or deposit account (but not a share account) at a branch (or the head office) located in England or Wales of a Building Society or Bank in each case in the name of the <i>CLC Body</i> and in the title of which account the word ' <i>Client</i> ' appears
Client Charter	The document which sets out in detail what all clients of <i>CLC</i> regulated firms can expect.
Client Money/Monies	any money held or received for a <i>Client</i> by a CLC regulated person or body incidental to the provision of legal services regulated by the <i>CLC</i>
Close Links	a situation in which two or more natural or legal persons are linked by control or participation, or a situation in which two or more natural or legal persons are permanently linked to one and the same person by a control relationship
Code of Conduct/CoC	the parent document of our <i>regulatory arrangements</i> , outlining the <i>Overriding Principles</i> which the regulated community must comply with and the <i>Outcome</i> s which they must deliver
Commissioner for	A public official whose main powers include administering oaths and

Communications	unless otherwise specified, communications sent by or on behalf of a <i>CLC</i> regulated individual or body by post, a telecommunication system or by other means whilst in an electronic form
Company	has the meaning given by s. 1(1) of the Companies Act 2006
Compensation Fund	as set out at s.21(2) of the <b>1985 Act</b> , the fund out of which grants and other payments are made by the <b>CLC</b> for the purposes of relieving or mitigating losses incurred by persons in consequence of the negligence, fraud or other dishonesty, or failure to account, on the part of a <b>CLC Body</b> .
Complaint	an oral or written expression of dissatisfaction which alleges that the complainant has suffered (or may suffer) financial loss, distress, inconvenience or detriment
Completion	Completion is the day when the buyer becomes the legal owner of a property, on receipt of the monies due.
Composite licence	authorisations on a <b>licensed conveyancer's licence</b> which give authority to the regulated individual to carry on additional <b>reserved legal</b> activities e.g. <b>probate, litigation*, advocacy*</b>
	*only applicable if the <b>CLC</b> 's application to regulate these services is successful.
Condition (licence)	where a risk is identified to the regulatory <b>outcome</b> s a condition is imposed on a <b>licence</b> to eliminate that risk or reduce it to an acceptable level
Conflict(s) of Interest	situation in which an individual or body has an interest, or a party they are representing has such an interest, sufficient to appear to influence the objective exercise of their regulatory responsibilities, in particular the separate duties to act in the best interests of two or more <i>clients</i> in relation to the same or related matters
Continuing Professional Development	the means by which members of the regulated community maintain, improve and broaden their knowledge and skills, keeping themselves up to date with the latest development in the profession and its markets and so enabling them to meet their full potential and provide <i>Clients</i> with high levels of service
Control (of an entity)	the strategic management, risk management, accounting and financial controls (including supervisory and audit functions) and from which services which consist of or include the <i>carrying on</i> of <i>reserved legal activities</i> are provided
Controls	strategic management, risk management, accounting and financial arrangements (including supervisory and audit functions) which eliminate or reduce to acceptable levels risks to positive <i>Outcomes</i>

Conveyancing Licence	a <i>licence</i> issued by the <i>CLC</i> to provide <i>conveyancing services</i>
Conveyancing (Services)	as defined at s.11(3) of the <b>1985 Act</b> , includes the preparation of transfers, conveyances, contracts and other documents in connection with, and other services ancillary to, the disposition or acquisition of estates or interests in land
Conveyancing Services Body	a body recognised by the <i>CLC</i> as a <i>Recognised Body</i> to provide <i>conveyancing</i> services and may in addition be licensed to provide <i>probate</i> , <i>litigation</i> or <i>advocacy</i> activities
Costs	in relation to costs to <i>Clients</i> this includes fees, charges, expenses and remuneration charged to the <i>Client</i> by the <i>CLC</i> regulated person or body and any Value Added Tax element includes fees as defined by s.39(1) of the <i>1985</i> **Act - "fees" includes charges, <i>disbursements</i> , expenses and remuneration
Customer Due Diligence (CDD)	<ul> <li>"Customer Due Diligence measures" (as defined by regulation 27 ML Regulations);</li> <li>"Ongoing Monitoring" (as defined by Regulation 8(2) ML Regulations);</li> <li>"Enhanced Customer Due Diligence measures" (as described in regulation 14 ML Regulations);</li> </ul>

Disbursements	any payment made, or for which a liability to pay has been incurred, by a <i>CLC</i> regulated individual or body to a third party on behalf of a <i>Client</i> ; disbursements are deemed to include: stamp duty land tax; Land Registry fees; <i>Local Authority</i> and any other applicable search fees
Discipline and Appeals Committee (DAC)	committee established under s.25 of the <b>1985 Act</b> to hear and determine appeals and cases referred to it (the functions of which are now exercised by the <b>Adjudication Panel)</b>
Distant Marketing Regulations	The Financial Services (Distance Marketing) Regulations 2004 (SI 2004/2095) implementing Directive 2002/65/EC
Divestiture	the procedure set out at Part 5 schedule 13 of the <b>2007</b> Act by which the <b>CLC</b> may apply to the High Court for an order for sale of all or some of the shares held by the holder of a material interest in a <b>CLC</b> Licensed Body who is not an <b>Authorised Person</b>
Durable Medium	means any instrument which:

(a) enables a customer to store information addressed personally to that customer in a way accessible for future reference and for a period of time adequate for the purposes of the information; and
(b) allows the unchanged reproduction of the information stored

<u>E</u>

Employee	(depending on the context) an individual employed by a <i>CLC</i> body, by an entity regulated by another legal regulator or by a <i>local authority</i> or other employer
Enforcement	action taken by the <i>CLC</i> in response to a <i>CLC</i> regulated individual or body acting in breach of their/its regulatory responsibilities
<b>Equalities Legislation</b>	the Equality Act 2010 and any other relevant legislation such as the Human Rights Act 1998
Estate	the whole of a person's possessions, especially all the property and debts left by them upon their death.
EU Body	an entity providing <i>reserved legal activities</i> in respect of which Control is maintained from a permanent fixed address within the European Union (but outside England and Wales)
EU Home Professional Rules	the professional rules which authorise the European Lawyer and the EU body of which the European Lawyer is a <i>Manager</i> to practise in a state within the European Union (but not England and Wales)
EU Professional Cover	<b>professional indemnity insurance</b> cover provided to the EU Body in accordance with its EU Home Professional Rules which the <b>CLC</b> is satisfied is in all respects equivalent in its conditions and extent to that which would be provided under the <b>CLC PII Policy Terms</b>
EU Professional Cover – Partial	professional indemnity insurance cover provided to the EU Body in accordance with its EU Home Professional Rules which the CLC is satisfied is only partially equivalent in its conditions and extent to that which would be provided under the CLC PII Policy Terms (and is likely to require a Supplemental Policy to accompany it)
European Lawyer	a European Lawyer as defined in the European Communities (Lawyer's Practice) Regulations 2000 (SI 2000 No 1119) who is not an <i>Authorised Person</i>
Evidence of Insurance	evidence that the insured individual or body has appropriate <i>PII</i> cover

Example Approach/Policy/ Procedure	guidance documents sometimes provide a possible route to the positive outcomes sought, but importantly are not the only route; if a member of the regulated community is able to generate the same or better outcomes another way they are encouraged to do so
Exchange of contracts	This is the point at which signed contracts from the buyer and seller are exchanged and a deposit paid.
Exempt Person – 2007 Act	as defined in Schedule 3 and paragraph 13 and 18 of Schedule 5 of the <b>2007</b> **Act, a person who is exempt from being an **Authorised Person* in relation to a *reserved legal activity
Exempt Person – FSMA	as defined in s.417(1) FSMA, in relation to a Regulated Activity, a person who is exempt from the General Prohibition in respect of that activity

	the statute which provides the framework within which the regulator for the financial services industry, the Financial Conduct Authority operates
Fit & Proper Person	the <i>CLC</i> requires that all:
	• applicants;
	authorised persons;
	• owners or managers of an Alternative Business Structure;
	are able to demonstrate that they are suitable for the role for which they are applying, this includes a fit and proper test to determine their probity and financial history

General Prohibition	the prohibition imposed by s.19 of the FSMA which states that no person may carry on a Regulated Activity in the United Kingdom, or purport to do so, unless he is (a) an <i>Authorised Person</i> ; or (b) an Exempt Person
Guidance	many of our regulatory Codes are underpinned by guidance which identify considerations to be borne in mind when seeking to deliver the identified <i>outcome</i> s; the guidance provided is not mandatory

Head of Finance &	the officer in a <i>Licensed Body (ABS)</i> designated responsible for the body
Administration (HoFA)	complying with their accounts responsibilities as set out in our regulatory
	arrangements; the individual does not have to be an <i>Authorised Person</i> ; it is preferable, though not mandatory, for the individual to be a <i>manager</i>

Head of Legal Practice	the officer in a <i>Licensed Body (ABS)</i> designated responsible for the body
(HoLP)	complying with its responsibilities as set out in our <i>regulatory</i>

	preferable, though not mandatory, for the individual to be a <i>manager</i>

Improper influence	when a person – usually the <i>owner</i> - attempts to influence the decisions of the <i>Licensed (ABS) Body</i> or the conduct of <i>Authorised Persons</i> in a way which would constitute a breach of licensing requirements and of regulatory duties
Insolvency (event)	(a) resolution for a voluntary winding up of the body is passed without a solvency declaration (under s.89 of the Insolvency Act 1986);
	(b) the body enters administration under the meaning of Schedule B1, para 1(2)(6) of that Act;
	(c) an administrative receiver within s.251 of that Act is appointed;
	<ul><li>(d) a meeting of creditors – which has the effect of converting a members' voluntary winding up into a creditor's voluntary winding up – is held in relation to the body under s.95 of that Act;</li></ul>

	(b) life insurance contracts where the benefits under the contract are payable only on death or in respect of incapacity due to injury, sickness or disability;
	(c) pension products which, under national law, are recognised as having the primary purpose of providing the investor with an income in retirement, and which entitle the investor to certain benefits;
	(d) officially recognised occupational pension schemes falling under the scope of Directive 2003/41/EC or Directive 2009/138/EC;
	(e) individual pension products for which a financial contribution from the employer is required by national law and where the employer or the employee has no choice as to the pension product or provider

Insurance Distribution Directive (IDD)	Directive No 2016/97/EU
Insurance Distributor	any Insurance Intermediary, Ancillary Insurance Intermediary or Insurance Undertaking
Insurance Distribution Activities	the activities of advising on, proposing, or carrying out other work preparatory to the conclusion of contracts of insurance, of concluding such contracts, or of assisting in the administration and performance of such contracts, in particular in the event of a claim, including the provision of information concerning one or more insurance contracts in accordance with criteria selected by Clients through a website or other media and the compilation of an insurance product ranking list, including price and product comparison, or a discount on the price of an insurance contract, when the Client is able to directly or indirectly conclude an insurance contract using a website or other media
Insurance Intermediary	any natural or legal person, other than an insurance or reinsurance undertaking or their employees and other than an ancillary insurance intermediary, who, for remuneration, takes up or pursues the activity of insurance distribution
Insurance Intermediaries Register	the record maintained by the Financial Conduct Authority under s.347 FSMA
Insurance Undertaking	means an undertaking as defined in Article 13 point 1 of Directive 2009/138/EC of the European Parliament and of the Council
Intended licence	under the Student Training Framework this means the <i>licence</i> that an   applicant is intending to train to acquire:  a. a conveyancing licence; and/or  b. a probate licence; and/or
	c. a <i>litigation licence</i> ; and/or
	d. an <i>advocacy licence</i>
Intervention	a legal process whereby an agent is appointed to organise the formal closure of the business

Large Risks Insurance	contracts of insurance covering risks within the following categories, in accordance with article 13(27) of Directive No 2009/138/EC:

	(b) <u>credit</u> and <u>suretyship</u> , where the policyholder is engaged professionally in an industrial or commercial activity or in one of the liberal professions, and the risks relate to such activity;
